




FORSYTH COUNTY SHERIFF'S OFFICE

Mid 2019 we introduced our newest Forsyth County Jail Inmate program, Pups with Purpose. Pups with Purpose inmate training program is a unique partnership between the Forsyth County Sheriff's Office, dog trainer Scot Rucker, and the Forsyth County Animal Shelter. The program gives carefully selected inmates an opportunity to give back to society by providing foster care and basic obedience training to homeless, unwanted animals while enhancing the inmate's social and vocational skills, which can aid them in becoming productive Citizens after release. In addition, the program will ensure the rescued dog possesses the skills to enjoy a lifelong relationship with a loving adoptive family.

Class one entered the jail at the end of August 2019, and in its first four months saw great success.



\*One dog was adopted by a FCSO employee and will continue training as a therapy dog for the jail.

### MESSAGE FROM THE SHERIFF

I am pleased to present your 2019 annual report. Inside you will find a detailed look at the happenings of the Forsyth County Sheriff's Office (FCSO). You will find details on our crime statistics, financial accountability, and a detail of the incredible work the men and women of FCSO do every day.

Serving as your Sheriff is truly an incredible honor and trust that I strive to meet every day. Serving as your Sheriff for the last three-plus years has been the pinnacle of my law enforcement career. I work directly for you, our citizens, and not for any other branch of government. Call on me if I, or the FCSO, can be of assistance to you.

Our support from Forsyth citizens is the envy of every other Sheriff in Georgia. It is because of our trust and cooperation that we have such a safe community to live in. **On behalf of all of us at FCSO, thank you for your continued trust.** We enjoy a great working relationship with our Board of Commissioners and continue to work closely to support our citizens. Kudos to the Commissioners for their continued strong support of public safety needs.

Even in the face of continued and sustained growth, Forsyth County crime statistics are down significantly from 2018 and even more so from 2017. Few agencies could accomplish this in such a growth pattern and in such close proximity to Metro-Atlanta. We reduced burglaries, thefts, entering autos, and robberies by double-digit numbers, and our Deputies are some of the most highly trained in the state. We continue to be the safest Metro-Atlanta County with the lowest crime rates, which is a testament to the skill and dedication of the men and women of the FCSO.

Our commitment to school safety has never wavered, and the results of our 2018 School Safety task force have been implemented. Today we have 41 full-time Deputies assigned to school safety, including two full-time K-9 Narcotics teams. Working closely with our School System partners, we follow up intensely on any perceived or real threat and follow through non-stop until the threat is fully investigated. With new schools coming online, we are ready to meet that challenge as well.

In 2019 we received the highly coveted Commission on Law Enforcement Accreditation's Advanced Law Enforcement Accreditation award. The highest given by the Commission and places us squarely in the top 1% of agencies who can meet this rigorous standard. This truly is the blue ribbon seal of approval for law enforcement. For 2020, we are embarking on the

National Institute of Jail Operations Jail Accreditation to ensure our jail operations are operating at the highest standards.

We implemented several new groundbreaking programs for FCSO. Our Pups with Purpose (Jail Dog) program takes stray dogs from the local animal shelter who are facing possible euthanasia. These fur-rescues are placed inside the Forsyth County Jail, where inmates and specially trained Deputies train them beyond basic obedience, to a Canine Good Citizen level. These animals are incredibly well trained, and after just four months in 2019, we adopted out every dog in the program. It is an incredible program that benefits the inmates and pups alike. Additionally, we welcomed our first therapy K-9, Boo Berry. Our therapy dog assists child victims being interviewed, and thus far, Boo Berry has helped over a dozen child victims and helped bring some really bad guys to jail. Our Pups with Purpose program is currently training additional therapy dogs for local non-profits and other law enforcement agencies.

In 2020, we are beginning both a mental health grant aimed at reducing criminalization of those suffering from persistent mental health issues, as well as opening our own Regional Substance Abuse Treatment (RSAT) program for inmates. This RSAT program will keep local inmates here and provide them with education and substance abuse treatment. During which, these inmates will work on programs that benefit Forsyth County, such as our Inmate Litter Detail, Pups with Purpose, future Printing Program, or landscape maintenance of government facilities such as the National Guard Armory. I look forward to the difference these programs can make for every person involved.

It is my responsibility to not only keep Forsyth Safe, but to be a good steward of the tax dollars which fund FCSO. We again met our financial goals, finishing nearly 1.3 million dollars under budget and returning those taxpayer dollars to the Board of Commissioners for future use. We continue to operate in a fiscally conservative manner and are committed to the wise use of taxpayer dollars.



**Grady D. Sanford, Jr.** *Chief Deputy* 



The Forsyth County Sheriff's Office was presented with two milestone awards in 2019. Advanced Accreditation from CALEA, the Commission on Accreditation for Law Enforcement Agencies, and State Certification from the Georgia Association of Chiefs of Police, which acknowledges the implementation of policies and procedures that are conceptually sound and operationally effective. These accreditations signify that FCSO is committed to maintaining the highest standards and accountability while meeting goals of excellence.



Members of the Forsyth County Sheriff's Office Traffic Enforcement Unit and senior Command Staff were honored to attend the 20th Georgia Governor's Office of Highway Safety Challenge Awards, where FCSO was awarded 1st place in the agency size category for strong efforts in Impaired Driving, Speed Enforcement, and Seatbelt/Child Restraint. FCSO was also presented with the Technology Award.





Several FCSO Deputies were recognized for their efforts during the 15th Annual Golden Shield Honors event presented by the Governor's Office of Highway Safety and MADD Georgia. This event recognizes law enforcement officers, agencies, DUI prosecutors, and community advocates for their efforts in keeping our highways and roads safe.



Detective Paige Simpson was presented a Tavern Plate Award by the U.S. Secret Service's Electronic Crimes Task Force for her accomplishments as a National Computer Forensic Institute (NCFI) Forensic Partner. Det. Simpson was top examiner out of the Atlanta Electronic Crimes Task Force and was ranked #31 (out 500+ agencies) in the entire U.S. Det. Simpson completed 236 digital forensic exams with a total of 57.81 TB of data.



The Sons of the American Revolution (SAR) awarded FCSO Deputy First Class John Crane the SAR Law Enforcement Commendation Medal. This award is presented to those who have served with distinction and devotion in the field of law enforcement and is intended to recognize exceptional service or accomplishment.

### **DEPUTY SPENCER ENGLETT**

On April 4th, 2019, Forsyth County Sheriff Deputy Spencer Englett suffered a medical emergency during his first day at Law Enforcement Academy and passed away. Deputy Englett was only 29 years old and had recently been married. He began his career at FCSO in 2017, working in the jail. Deputy Englett served Forsyth County with distinction and honor and will always remain well respected by his peers.



Operation Just Cause was a proactive multi-agency undercover investigation that took place in September in Forsyth County. The 4-day operation, which took several months of planning, resulted in 24 individuals being arrested with charges that included Computer or Electronic Pornography and Child Exploitation Prevention Act and Trafficking of Persons for Labor or Sexual Servitude.



### TRAFFIC RESPONSE VEHICLE

The Forsyth County Sheriff's Office Traffic Response Vehicle (TRV) officially launched in March of 2019. The TRV, much like GDOT's HERO truck, is designed to help residents with roadside problems and is in service Monday through Friday during rush hour times. The TRV team assists with stranded motorists, accidents, and road hazards, and they also enforce traffic laws.



We introduced the first FCSO Comfort Dog, Boo Berry, in September. Boo Berry completed comfort dog training along with her handler, Detective Jeff Roe. Boo Berry is certified in Canine Good Citizen which allows her and Det. Roe to work with child and adult crime victims. Boo Berry comes to the office with Det. Roe every day so she is available to provide some much-needed comfort when duty calls.

### LAW ENFORCEMENT BUREAU

The Law Enforcement Bureau is a major component of the Forsyth County Sheriff's Office and includes the Patrol Division (North and South), Criminal Investigations Division (CID), and Special Enforcement Division. Law Enforcement includes the prevention, detection, and investigation of crime and the apprehension of suspect violators of the law. Many specialized units fall within this bureau including JCAF Drug Task Force, School Resource, SWAT, K9, Traffic, and much more.

### CRIMINAL INVESTIGATIONS DIVISION

The Criminal Investigations Division (CID) is comprised of investigative units whose primary responsibility is to investigate and follow-up on crimes committed against persons or property in Forsyth County. CID is comprised of the Major Crimes Unit, Hi-Tech Crimes Unit, Property Crimes Unit, Narcotics Unit, SWAT & Crisis Negotiation Teams, and Peer Support Team.

### MAJOR CRIMES

The Major Crimes Unit of the Forsyth County Sheriff's Office is responsible for investigating all major crimes that occur within Forsyth County, with the exception of property crimes. Investigators within the Major Crimes Unit are tasked with providing follow up investigation on cases where a major crime has been committed but no arrest has been made, as well as initiating new cases independently. Cases involving violent acts and/or death, sexual assault, threats, etc. are classified as major crimes.

### **VICTIM ADVOCATES**

It has always been the policy of the Forsyth County Sheriff's Office to offer assistance to victims of crimes when responding to a call, but often times deputies have other calls to which they must immediately respond and cannot devote the time that the victim needs. Therefore our Victim Advocates assist victims of crime through the criminal justice system. Further, we know from first-hand experience that victimization does not end with the mire filing of a report to law enforcement, so Victim Advocates offer assistance throughout the criminal process.



### **PROPERTY CRIMES**

Property Crime Detectives of the Forsyth County Sheriff's Office are assigned to investigate and respond to calls and crime trends that need follow up by a trained investigator. Crimes investigated include, but are not limited to, burglaries, thefts, auto theft, entering autos, theft of trailers and large construction equipment.

### **HI-TECH CRIMES**

The Forsyth County Sheriff's Office Hi-Tech Crimes Unit investigates, tracks, and apprehends individuals involved in and participating in cyber-related crimes; including identity theft/white-collar crime, unauthorized computer access, cyberstalking, online child enticements and exploitation, the possession, distribution, and manufacturing of child pornography, and much more.

The Hi-Tech Crimes Unit is comprised of the Internet Crimes Against Children (ICAC), Hi-Tech Crimes, Sex offender Registry, and Crime Scene. ICAC Detectives work to safeguard children from sexual predators by investigating crimes involving child exploitation on the internet and track those involved with child pornography. Hi-Tech Crimes Detectives investigate the many other cyber-related crimes.

The Hi-Tech Crimes investigative teams also conduct forensic examinations of cell phones, computers, and other types of digital media seized in investigations.

White Collar Crimes fall under this unit as well. White collar investigations include the theft of credit and debit cards used in a fraudulent manner and forgery of any kind whether it be documents, checks, or unlawful signing of a name without one's permission.




### **NARCOTICS**

The Forsyth County Sheriff's Office Narcotics Unit is responsible for finding and investigating illegal narcotics use and distribution, as well as gambling, prostitution, and human trafficking within Forsyth County. This unit works hand-in-hand with the Major Crimes Unit.

These detectives are assigned county wide and work wherever they find illegal narcotics being manufactured, distributed, possessed, stored, or used. Vice type crimes like gambling, prostitution, and human trafficking are also investigated by our narcotics unit.



### UNIFORM PATROL DIVISION

The Forsyth County Sheriff's Office Uniform Patrol is comprised of both the North and South Patrol Precincts. Uniform Patrol as a whole is responsible for providing uniformed Deputies to manage and respond to calls for service, crime prevention, and maintain order.

### POP UNIT

The Uniform Patrol Division also includes the FCSO Problem-Oriented Policing (POP) Unit, which was developed to improve strategies that prevent and reduce crime. POP Deputies analyze crimes and problem areas within the community and search for effective solutions. Communication is key for our POPs team so they spend a lot of time out in the community talking with citizens and business owners in Forsyth County. The POP Unit also heads up the FCSO Business Watch program and the Neighborhood Watch program.

### LAW ENFORCEMENT BUREAU

### SPECIAL ENFORCEMENT DIVISION

The Headquarters Division provides administrative and logistical support to the agency. Major functions include Finance, IT, Records, GCIC, Evidence & Property, and Logistics. Staff in this division work closely with their counterparts throughout county government to ensure effective, efficient and policy-compliant operations.

### TRAFFIC UNIT


The Traffic Unit is responsible for keeping the roads safe. The Traffic Unit consists of the Governor's Office of Highway Safety H.E.A.T. (Highway Enforcement of Aggressive Driving) Unit and D.U.I. Task Force, and working alongside the Motorcycle Unit, Traffic Specialist Unit, K9 Unit, and a Traffic Response Vehicle.

### H.E.A.T. UNIT

The Forsyth County Sheriff's Office is proud of its partnership with the Georgia Governor's Office of Highway Safety (G.O.H.S.). In 2019, we continued our H.E.A.T. Unit program and received a grant


from the Governor's Office for our enforcement and educational efforts.

The mission statement for the H.E.A.T. members is to reduce accidents, fatalities, and serious injuries through education and enforcement. The H.E.A.T. Unit members aggressively target unsafe driving behavior in the areas of D.U.I., speeding, occupant protection, and distracted driving. They also spend time on educational efforts. The H.E.A.T. members are commonly requested to teach at schools, businesses, and community events to educate the public about Traffic Safety issues.



### TRAFFIC SPECIALIST UNIT


The Traffic Specialist Unit consists of a specially trained team that investigates serious injury and fatal traffic crashes, as well as hit and run incidents in Forsyth County. Traffic Specialist Deputies are equipped with numerous state-of-the-art pieces of equipment, including the Total Station System which is used to map a crash or crime scene to scale, a Bosch Crash Data Retrieval System that retrieves crash data from an air bag module, and other critical investigative software and hardware. Most of this equipment was purchased using drug seizure funds, at no cost to taxpayers.




Car crashes with injuries (reported, serious and fatalities)

### MOTORS UNIT

The Motor Unit is tasked with aggressive traffic enforcement, targeting high traffic crash areas and complaints from citizens of traffic issues. The Motor Unit also oversees deploying "Speed Smart Trailers" and TraxxPro devices. These devices help the agency target dates and times to best focus on speed enforcement, as well as educating the public on speeding issues. The Motor Unit is also responsible for funeral escorts and other special assignments.





### **K9 UNIT**

The K9 Unit consists of four Dual Purpose Canine and Deputy Teams. The primary duties of the K9 Unit include, but are not limited to:

- Tracking lost or missing persons
- Tracking suspects engaged in criminal activities
- Evidence recovery
- Lost property recovery
- Assisting in high risk warrants
- Locating illicit narcotics

The unit works throughout the county and has assisted other agencies when needed. Our Dual Purpose Canine Teams train daily and meet four times a month to conduct scenario based K9 training.

### TRAFFIC RESPONSE VEHICLE

The Traffic Response Vehicle (TRV), much like the Georgia Department of Transportation's HERO truck is designed to help residents with roadside problems. However, the FCSO Traffic Response Vehicle also enforces laws and issues citations as needed. The TRV Unit patrols high-traffic county roads and provides roadside help during busy weekday rush hours.

### SCHOOL RESOURCE (SRO)

The Forsyth County Sheriff's Office School Resource Officer Unit falls under the Law Enforcement Bureau, and is committed to working closely with the Forsyth County Board of Education and School Safety Department to maximize the safety of our most valuable treasure, our youth. Sheriff Freeman and the Board of Education have developed a plan to staff a minimum of one SRO at each public school campus in Forsyth County. School resource officers protect nearly 50,000 students, plus staff, within 38 school campuses. The SRO deputies provide direct services to the schools; which include campus safety inspections, classroom presentations, criminal investigations, student and parent conferences, along with a variety of other activities including traditional law enforcement duties and security.



A **School Safety Task Force** was established in early 2018 by Forsyth County Schools Superintendent Dr. Bearden and Forsyth County Sheriff Freeman, with an objective of completing a comprehensive safety assessment of all Forsyth County school campuses and review of possible security improvements. The task force is led by the Forsyth County Sheriff's Office and includes staff from Forsyth County Schools and representatives from both the Forsyth County Fire Department and Forsyth County Emergency Management Agency.

The School Safety Task Force completed a review of existing policies and conducted physical surveys of all Forsyth County public school campuses. They engaged the community on ideas and concerns as security needs were reviewed. The task force prepared a thorough report of their findings and recommended potential safety improvements. This report was presented to both Sheriff Freeman and Dr. Bearden, aiding decisions made on what steps can be taken to further ensure the safety of our children and school staff. The Forsyth County Sheriff's Office will always be committed to securing the safety of our schools and will continue to have enhanced presence on all campuses.

### **VOLUNTEERS**

The Forsyth County Sheriff's Office is grateful to have numerous volunteers and reserve deputies who drop everything to help when called upon, receiving nothing in return. Our volunteers are vital to our day to day operations and play a large part in our mission to keep Forsyth safe. Some of our volunteer opportunities include administration, Community Emergency Response Team (CERT), and Citizens Helping in Policing (CHIP).



In 2019, the Forsyth County Sheriff's Office Volunteers, including CERT, ARES, CHIP, Explorers, and FCSO Reserve Deputies, worked a total of 13,886 hours. The total number of hours worked is equivalent to just over 7 full-time employees. This equals a savings of \$477,144 to the citizens of Forsyth County.









### CITIZENS HELPING IN POLICING

The mission of the Forsyth County Sheriff's Office Citizens Helping In Policing (CHIP) is to help improve the quality of life for Forsyth County residents and visitors by providing visible presence and by observing and reporting suspicious activities. This mission is accomplished through a collaborative partnership with the residents of Forsyth County and the Forsyth County Sheriff's Office.

The CHIP team members help the Sheriff's Office and the community in many ways. This includes assisting with special events, traffic direction, residential and business checks, park patrol, and other types of support functions.



### **COMMUNITY EMERGENCY RESPONSE**

The Community Emergency Response Team (CERT) program educates volunteers about disaster preparedness for the hazards that may impact their area and trains them in basic disaster response skills; including fire safety, light search and rescue, team organization, and disaster medical operations. CERT offers a consistent, nationwide approach to volunteer training and organization that professional responders can rely on during disaster situations, which allows them to focus on more complex tasks. CERT volunteers are trained to respond safely, responsibly, and effectively to emergency situations, but they can also support their communities during non-emergency events as well.

### FCSO CHAPLAINS

The Forsyth County Sheriff's Office Chaplain Corps recognizes the stressful situations encountered and the personal sacrifices made on a daily basis by the professional employees of the agency and their families. The Chaplain Corps' passion is to build personal relationships with each employee and provide spiritual guidance, counseling and emotional support. They also serve as Sheriff's Office representatives to the faith community and the community at large.

## 6200 JAIL BOOKINGS



The Jail Bureau is comprised of two divisions, Operations and Security, as well as a Grievance Deputy who reports directly to the Jail bureau Commander. The Grievance Deputy is used as a non-partial person to handle grievances submitted by inmates in regards to jail staff, contractors, or other inmate concerns.

### SECURITY DIVISION

The Jail's Security Division consists of four Watches, each working 12 hour shifts. Each watch consists of approximately twenty three persons and includes the direct line supervision of seventeen Deputies and three Inmate Service Specialist by a Lieutenant, Sergeant, and Corporal.

The Security Division has many roles within the jail; however, the most important role is the management of all inmate housing areas. There are fourteen inmate housing areas, as well as an Infirmary. The Infirmary sees and treats inmates with medical issues, mental health issues, and suicide watches. Flex Housing is utilized for discipline issues, sex offenders, and housing the administrative segregation population which consists of individuals with mental health issues, those in protective custody, or the high profile.

All arrestees in the Forsyth County jurisdiction and geographic area are brought to the detention center for intake. The arrestees may be brought in by the Sheriff's Office, City Police, Department of Natural Resource, Georgia Bureau of Investigations, Corp of Engineers, or Georgia State Patrol. The Security Division is responsible for fingerprinting, photographing, and confirming the identification of all intakes. After an inmate is processed in booking,

it is the responsibility of the deputies in this division to insure the safety, security, medical, and dietary needs of each inmate is met. Inmates are given an Inmate handbook and are expected to comply with its content; however, it is the Security Division that ensures compliance and addresses any violations.

Briefly, other essential functions of the Security Division include, but are not limited

- Jail Deputy training
- Manage Inmates working the kitchen
- Inmate movement for court appearances, visitation, meetings with evaluators, etc.
- Random and scheduled contraband
- Nightly sweeps inside and outside the
- Inmate booking and classification
- Inmate background checks
- Inmate property custodians

Within the Security Division, is a specialized team, the Jail Special Response Unit. SRU is trained to handle riots, unruly inmates, mass movements of inmates from one location to another, large scale shakedowns and hostage situations.

### OPERATIONS DIVISION

The Jail's Operations Division consists of nine Civilians, four Transport Deputies, three Jail Resource Deputies, one Litter Patrol Deputy, as well as a Sergeant, a Corporal, and a Administrative Support Supervisor who are the direct line supervision for Operations. There are several areas, with many responsibilities, within the Jail Operations Division. These areas include Administrative, Communications, Resources, Litter Detail, Transportation, and Programs.

The essential functions of the Operations Division include, but are not limited to:

- Documentation and records
- Bonding processes and records
- Inmate court files
- Security control and communications
- Inmate transportation; on and off site
- Inmate release
- Jail sanitation and maintenance
- Inmate laundry
- Kitchen security
- Support and supplies for facility
- Supervision of inmate workers who cut grass, pick up litter, and move equipment for the entire Sheriff's Office, Georgia State Patrol, and National Guard.

Another key function of the Operations Division is the Programs Unit. This unit not only provides the service of book carts, a law library, and notary for the inmates, it also coordinates several activities and beneficial programs for inmates housed in the Jail. Through partnerships with a great number of community volunteers we are able to provide the following programs to our inmates:

- GED training and testing (through Lanier Tech)
- Continued high school education (through Forsyth County Board of Education)
- Church Ministry
- Alcoholics Anonymous
- Narcotics Anonymous
- Transition Classes; including anger management, parenting skills, budgeting and managing money, listening skills, and interviewing techniques
- Celebrate Recovery



The Litter Detail Deputy coordinates with Forsyth County Clean and Beautiful for road clean up. The Deputy supervises four inmates who perform county roadside trash removal.

In 2019, the Jail Litter Detail collected a total of 35,920 pounds of litter in Forsyth County.

### SHERIFF'S SERVICES BUREAU

The Sheriff's Services Bureau provides services to the community for which the Office of the Sheriff is constitutionally responsible, and provides administrative and logistical support to the agency. The Bureau is comprised of three divisions: Judicial Operations, Training, and Headquarters, as well as the Policy and Accreditation function.

### **JUDICIAL OPERATIONS DIVISION**

The Judicial Operations Division includes the Judicial Security Section, the Judicial Enforcement Section, and the Ordinance & Permits Unit.

### **JUDICIAL ENFORCEMENT SECTION**

The Judicial Enforcement Section consists of the Warrant and Civil Process Units. The Warrant Unit is charged with locating and apprehending fugitives from justice. Warrant deputies work closely with Forsyth County prosecutors and courts, and with other local, state and Federal agencies. In addition to serving Forsyth County warrants, a deputy from this Unit is assigned to the U.S. Marshals Service's Fugitive Task Force.

Judicial Enforcement also includes the Civil Process Unit, which provides personal service of official court papers such as summonses, civil complaints, protection orders, and other documents pertaining to legal proceedings. The Civil Unit also facilitates activities such as evictions, property pick-ups, and court-ordered seizures.

### **JUDICIAL SECURITY SECTION**

The Judicial Security Section is responsible for security at the county's four court buildings, the County Administration Building and Tax Commissioner's offices, and for the safety of staff and visitors in those facilities. Deputies assigned to this Section are trained in courtroom security, access control, inmate movement and emergency response, using a variety of tools and technologies.

### **ORDINANCE & PERMITS UNIT**

The Ordinance and Permits Unit provides fingerprint and criminal history services to Forsyth County residents for a variety of purposes such as employment, adoption, firearms licenses, and alcohol permits. The Unit also enforces certain county ordinances, with an emphasis on quality of life and safety concerns. Areas of focus include the sale of alcohol, vape and nontraditional tobacco products, and spa and massage businesses. The Permit Office is open to the public during normal business hours.

### TRAINING DIVISION

The mission of the Training Division is to ensure that Forsyth County deputies are highly trained in the law, and in the skills needed to provide exemplary service to the community. Dedicated instructors provide annual training and conduct assessments in a wide range of fields such as tactics, firearms, driving, deescalation/negotiation, emergency medicine, and more. Much of this training is also open to sworn personnel from other agencies in the region, and in 2019 classes, were attended by deputies and police officers from all over the North Georgia area.

In addition to regular, ongoing training, 2019 saw new initiatives in several key areas. New courses were offered toward Intermediate and Advanced peace officer certification. Annual training was added for civilian employees in the areas of dealing with the mentally ill, recognizing signs of domestic violence and abuse, and First Aid/CPR. And in collaboration with the Forsyth County Fire Department and Department of Emergency Management, deputies trained in coordinated responses to large-scale emergency and mass casualty events.

The Training Division is also responsible for the agency's weapons. This includes evaluating and acquiring firearms and less-lethal weapons and accessories, issuing and qualifying deputies with weapons, training in proper use of force, and maintaining all related records.

Finally, and significantly, the Training Division reviews all incidents involving vehicle pursuits and uses of force. The purposes of these reviews are to monitor compliance with legal standards and agency policy, and to gather practical feedback on training doctrine and approaches.

### POLICY & ACCREDITATION

The Policy and Accreditation function is responsible for maintaining state certification and international accreditation, and for ensuring that agency policies and procedures meet the highest standards in law enforcement.

The Forsyth County Sheriff's Office is presently certified in Georgia through the Georgia Association of Chiefs of Police. Certification recognizes compliance with 123 different best practice standards comprising 324 individual requirements. The agency also holds Advance Accreditation from the Commission on

Accreditation for Law Enforcement Agencies. This internationally-recognized accreditation recognizes compliance with 504 different standards comprising 1,071 individual requirements.

The newest accreditation initiative for the Forsyth County Sheriff's Office is achieving jail accreditation through the National Institute for Jail Operations. This effort, which began in November of 2019, will require complying with approximately 600 standards addressing all aspects of jail operations.

### SHERIFF'S SERVICES BUREAU

### **HEADQUARTERS DIVISION**

The Headquarters Division provides administrative and logistical support to the agency. Major functions include Finance, IT, Records, GCIC, Evidence & Property, and Logistics. Staff in this division work closely with their counterparts throughout county government to ensure effective, efficient and policycompliant operations.

### INFORMATION TECHNOLOGY UNIT

The Sheriff's Office Information Technology (SOIT) Unit helps identify, select, implement and support technologies appropriate to the agency's mission. Examples include computing, communications, audio and video capture, records management, and vehicle-installed electronics. A primary focus of the SOIT Unit is the security and reliability of Sheriff's Office systems and data.

### LOGISTICS UNIT

The Logistics Unit is responsible for purchasing, equipping and maintaining the Sheriff's Office's fleet of more than 350 vehicles, and for quartermaster functions. Fleet responsibilities include working with manufacturers and dealers, the county Fleet Department, local service firms, and other partners to ensure the safe and reliable condition of every vehicle. Quartermaster responsibilities include issuing proper uniforms, duty gear and other equipment to all 450+ employees.



### **RECORDS UNIT**

The Records Unit is the official repository of incident reports, crash reports, citations, inmate records, and other documentation of Sheriff's Office activity. The Unit is responsible for the preservation and production of such records in compliance with applicable laws governing record retention and release. The Unit is open to the public during normal business hours. In 2019, the unit provided 1,893 reports.

### GCIC UNIT

The GCIC (Georgia Crime Information Center) Unit is responsible for the entry, maintenance, retrieval and control of all information that falls within the scope of the Georgia Crime Information Center. Such information includes active arrest warrants, stolen item files, missing persons, and other law enforcement-sensitive records. The Unit is also responsible for institutional and individual compliance with GCIC rules and state law. In 2019, the unit processed 41,992 GCIC queries and made 11,106 GCIC entries.

### **EVIDENCE & PROPERTY UNIT**


The Evidence and Property Unit maintains custody of all evidentiary material, and property that has been confiscated under a court order or turned over to the Sheriff's Office for safekeeping. The Unit stores and maintains detailed and accurate records of tens of thousands of items, most of which are subject to court orders for production, retention, and ultimately destruction or disposal. In 2019, the Evidence and Property Unit logged 5,929 items of evidence and destroyed 1,958 pounds of drugs.


### **FINANCE UNIT**

The Finance Unit is responsible for budgeting and financial reporting, banking, payroll, purchasing and contact administration, inventory control, grant administration and accounting functions specific to the Sheriff's Office.

### 2019 FINANCIAL BREAKDOWN

- For fiscal year 2018, FCSO's actual expenditures were \$43.2M versus a revised budget of \$44.9M, the Sheriff's Office ended 2018 approximately \$670K under revised budget.
- For fiscal year 2019, FCSO's actual expenditures were \$45.5M versus a revised budget of \$46.8M, the Sheriff's Office ended 2019 approximately \$1.3M under revised budget.

### COMMUNITY RELATIONS The Community Poletions Unit

The Community Relations Unit serves to promote safety and education to the citizens and businesses of Forsyth County, and is a vital component of the Forsyth County Sheriff's Office. The FCSO Community Relations Unit is responsible for coordinating and delivering special classes and programs that work to better build the relationship between the community and the Sheriff's Office.

Along with the many classes and programs offered by FCSO Community Relations, they also partner with other organizations throughout the year and attend many other community events. In 2019, the Community Relations team attended more than 31 additional events; including safety fairs, family events, fundraisers, 5K races, and more.

### **PROGRAMS**

### **SALT (Seniors and Lawmen Together)**

Open to all Forsyth County Senior Citizens and held monthly. Each month features different speakers and different topics pertaining to senior safety.

### **CLEA** (Citizens Law Enforcement Academy)

The program closely follows the actual handson training that deputies undergo. Topics include constitutional law, conducting traffic stops, judgmental use of force, K9 and S.W.A.T. demonstrations, ridealong with deputies, and much more.

### **TIP** (Teen Interception program)

With a sole purpose of saving teen lives by redirecting them to make better choices and to live successful lives. This seven-week program includes several key speakers and trips to a funeral home, the Forsyth County Jail, and a homeless compound in Atlanta.

### CLASSES

### **Women's Self Defense**

Designed to teach women situational awareness.

**CRASE** (Citizens Response to Active Shooter Event) Intended to teach what to do/not do in the case of an active shooter. The skills taught are to Avoid, Deny and Defend-STAY ALIVE and Survive!

### Stranger Danger

Educates and empowers children ages 4-11 with knowledge and skills that will help them be safer from various crimes against children.

### RECRUITMENT

The Forsyth County Sheriff's Office Recruitment Unit is responsible for promoting FCSO careers in locations such as colleges, technical schools, military posts, and other events. **Chief Deputy William Cantrell** End of Watch 1.10.1972

On January 10th, 1972 Chief Deputy Cantrell along with his partner, Deputy Mulkey, were shot and killed after being abducted during a traffic stop. Both deputies were found in the trunk of their patrol car suffering from gunshot wounds



**Deputy Sheriff Larry Mulkey** End of Watch 1.10.1972

Deputy Mulkey died in the line of duty as he patrolled with Chief Cantrell. After the two were discovered, a piece of paper containing the tag number of the suspect's vehicle was found hidden in Deputy Mulkey's handwriting. This evidence led to the arrest and conviction of the suspects.



**Deputy Sheriff L. Charles Outz** End of Watch 9.23.1993

Deputy Outz suffered from a heart attack while transporting an inmate. During his time with FCSO, Deputy Outz worked in Uniform Patrol, Court Security,



Sergeant David P. Land End of Watch 3.26.2003
